AFFIDAVIT ON COMPLAINT
(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Det. Brian M. Taylor, do hereby state that I am employed at the Celina Police Department. The following did occur:

On April 13, 2025, Officers were dispatched to a business, Victim # 1, located at 1950 Havemann Road, Celina, Mercer County, Ohio, to report that their vehicle was stolen. Shortly after that call, someone called the Police Department and reported a possible theft of items, from Victim # 1, because they witnessed them loading items into a vehicle.

I arrived and spoke with Samuel Bibbs. Bibbs said that he was in the parking lot of Bob Evans Restaurant when two males and female approached him, assaulted him and took his car keys. They took his Cadillac Escalade, drove over to Victim # 1, stole store merchandise and put the merchandise into his vehicle.

I went to Victim # 1 and spoke with the Asset Protection Manager. We reviewed surveillance videos. I watched the Escalade enter the parking lot, to Victim # 1, and park in Aisle 8. Four people exited the vehicle, including Bibbs. Bibbs stays outside and the other males and female go in. One of the males came back with items and loaded them into the Escalade. They were found to be stolen. Bibbs can be seen communicating with the male. The stolen vehicle was never in the Bob Evans parking lot.

We recontacted Bibbs to speak with him a second time. He was placed under arrest for filing a false police report. We read Bibbs his Miranda Rights. He changed his story and said that he owed somebody money, so he brought these two people to Victim # 1 to help pay off his debt. He said that he knew they were going to commit theft.

While speaking with Bibbs, we asked if he had any drugs on him. He admitted to having crack cocaine in his sock. I removed his left sock and found a small clear baggy that contained several white rocks that, from my training and experience, is crack cocaine.

Bibb was transported and booked into the Mercer County Detention Facility.
