
I, Chief Mike Link, do hereby state that I am employed at the St. Henry Police Department. The following did occur:

On May 26, 2025 at approximately 11:19 P.M, I was made aware of an active domestic violence occurring at 311 North Eastern Street, Saint Henry, Ohio. When I arrived, I saw a male that I recognized as Kial Burrows, walking towards Deputy Gruss and myself. He was saying that his wife, victim # 1 was keeping keys away from him and he was going to lose his job. I asked him if anything physical happened between them. He said that there was no violence. Kial continued to talk about how Victim # 1 made him break items in the home. Burrows did have blood on the middle knuckle on one of his hands.


I went to speak with Victim # 1. She said on Friday, May 23, 2025, Kial punched her in the head and left a bruise. I did notice a bruise behind her ear. She said that he also punched her on Friday. Today, Kial overslept, and she didn't want to awaken him, because all of the issues they have been having. When awake, he then accused her of hiding his car keys. She went on to say that she was then sitting in a bean bag chair and he attacked her trying to take her phone. He then started to choke her and said, "you're taking everything away from me." She said that while he was choking her, she had a hard time breathing.

After taking Victim # 1's statement, I talked to Kial again. Kial did admit to being on top of Victim # 1, while he was trying to get his phone.

Kial was placed under arrest and transported to the Mercer County Detention Facility. I also found that Kial Burrows had previously been convicted of Domestic Violence, in Celina Municipal Court on June 6, 2022, in case number CRB2200246.
