MOTION TO REVOKE BOND

The State of Ohio respectfully submits this motion requesting the Court to revoke Defendant's bond. On February 5, 2025, Defendant was released on his own recognizance with several conditions, including: Defendant not consume illegal narcotics; Defendant not test positive for illegal narcotics; and Defendant participate in the Probation Department's drug screening call-in program.

February 10, 2025, Defendant was selected to drug test, but he did not test. *See Exhibit A*, Affidavit of Dane A. Gross, Supervising Officer with the Mercer County Probation Department. On February 11, 2025, Defendant was selected to drug test and provided a urine specimen to Officer Gross. *Id.* The specimen tested positive for methamphetamines, amphetamines, cocaine, and THC.

Defendant's failure to drug test on February 10, 2025 and positive drug test on February 11, 2025 constitute direct violations of his bond conditions. Therefore, the State requests the Court revoke Defendant's bond and issue a bench warrant for Defendant's arrest.
