AFFIDAVIT ON COMPLAINT (O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Sgt. Colin Fuelling, do hereby state that I am employed at the Celina Police Department. The following did occur:

On April 29, 2025, at approximately 2:30 P.M, Officers were dispatched to 701 Grand Lake Road, Eastown Party Mart, for a report of drugs found in the store. Asst Chief Harting and I arrived and met with store employees.

The employees located a "small zip lock" baggie, on the floor, leading up to the counter. It contained a powdery substance that they believe is a drug of abuse. The contents, from my training and experience, are methamphetamine. After finding the baggie, the employees reviewed video surveillance footage. They saw a male, wearing a black shirt, with gray sweatpants with a "Boonie" hat hanging on his back. This male was in line and pulled out lottery tickets from his pocket. The Meth baggie fell out at the same time, unbeknownst to the male. We collected the evidence and left the store.

A short time later, an employee called and said that the male came back in and had since left riding a bicycle. They said that he left Southbound on Grand Lake Road. I found the male on his bike on Grand Lake Road by May Street. I contacted him on May Street.

The male was identified as being Charles Anthony Gibson and normally goes by the name Tony. I asked Tony about the Meth falling out of his pocket. He denied having Meth. He said that he was cashing lottery tickets for a female friend. Asst. Chief Harting arrived on scene and he too asked him about dropping the baggie. Gibson still denied it. We placed Gibson under arrest. While searching Tony, after arrest, he admitted that he had a pipe in his pocket. We located and retrieved a glass pipe that is commonly used for smoking Methamphetamine. He appeared to have residue inside it. It was located in a red handkerchief in his pocket.

Gibson was incarcerated into the Mercer County Detention Facility. Once at the Police Department, I field tested some of the contents of the baggie and it tested positive for Methamphetamine.
