AFFIDAVIT ON COMPLAINT (O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Patrolman Zac Nelson, do hereby state that I am employed at the Celina Police Department. The following did occur:

On March 26, 2025, at approximately 11:16 A.M, an on-duty Police Officer witnessed a Chevrolet Tahoe approach the intersection of Industrial Drive and Havemann Road, and fail to signal a turn, prior to 100 feet. Officers in a marked Police car initiated a traffic stop on the vehicle.

The driver of the Tahoe was identified to be Andrew Hesse.

A K-9 unit was requested and responded to the traffic stop. The handler utilized his K-9 and did a free air sniff around the Tahoe. Afterwards, the handler said that the dog alerted to the presence of an odor of narcotics.

Hesse voluntarily admitted that there was a syringe in the vehicle and that it had methamphetamine in it. Officers searched the Tahoe and located a syringe under the driver's seat. It did contain a crystal-like substance that from my training and experience is methamphetamine.

Hesse was found to be under an In-State Drug Suspension. He was transported to the Mercer County Detention Facility.

I was later made aware that Hesse had previously been convicted of a drug charge. He was convicted in Auglaize Common Pleas Court on March 13, 2022, for a single count of Drug Possession in violation of ORC 2925.11A.
