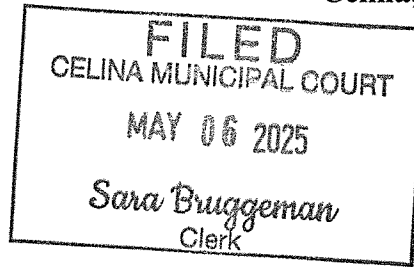

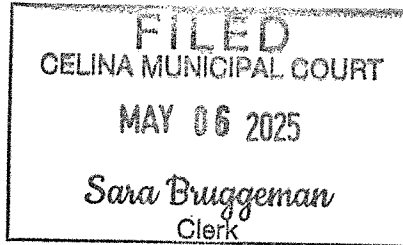

Complainant being duly sworn states that Jacob N. Hill at Mercer County, Ohio, on or about May 5th, 2025, did, recklessly cause inconvenience, annoyance or alarm to another by making unreasonable noise or an offensively coarse utterance, gesture or display, or communicating grossly abusive language to any person, to wit; Jacob N. Hill did recklessly cause annoyance by making unreasonable noise by yelling at officers while they were investigating an assault. Jacob N. Hill was warned by Ptl. Kuhlman to desist in the yelling. When Jacob N. Hill was placed under arrest he began yelling again and resisted arrest. Jacob N. Hill has thereby committed a Misdemeanor of the Fourth Degree, in violation of Ohio Revised Code 2917.11(A)(2).
