STATE OF OHIO, MERCER COUNTY, SS:

I, Officer Lucas Wolfe, do hereby state that I am employed at the Coldwater Police Department. The following did occur:

On February 24, 2025, I initiated an investigation involving Christina Borger. Borger wanted to make a complaint involving her juvenile daughter and her juvenile niece. She said that these girls have been harassed by a boy named Joseph Taylor, who is 18 years of age. Christina has told Taylor numerous times to stop contacting them, but he continues. Taylor told Christina that her niece, Victim # 1, was his and no one else was going to have her. Christina resides in Wapakoneta, Ohio so I referred her to authorities in that jurisdiction.

I went to the Coldwater High School and spoke with Principal Hemmelgarn about the situation. He said that he had Taylor and Victim # 1 in his office, earlier today. He told Taylor to stop emailing and contacting Victim # 1. I requested emails between the two. The school said that they would try to get those.

On February 24, 2025, I contacted VR #1, Victim #1's father. I made him aware of the allegations and he said that he would follow up with Victim #1 about the situation and get back with me.

Wapakoneta Police Department contacted me and asked that I make contact with Joseph 1 2 2025 Taylor and tell him to stop contacting Borger and her family and warn him for telecommunication harassment.

On February 24, 2025, I went to 605 North Seventh Street in Coldwater to speak with Taylor. I made contact with Taylor and warned him about further contact with Borger and her family. I spoke with him about Victim #1. Taylor admitted that he contacted Victim #1 after being told not to by Mr. Hemmelgarn at the school. I gave Taylor a warning about contact with Victim #1 in the future.

On February 25, 2025, I was contacted by VR #1. He said that he spoke with Victim # 1, and she did feel like she was being harassed by Joseph Taylor.

On February 26, 2025, I spoke with Victim # 1 and VR #1. Victim # 1 said that Taylor doesn't understand that they are not seeing each other anymore. Victim # 1 went on to say that Taylor spoke with her this morning, and she didn't want to. He asked for a hug, and she said no. After this, Taylor started emailing her. As I spoke with Victim # 1 more, she said that

She said that these were through the social media site "Snapchat." VR #1 asked that I inform Taylor to stop trying to communicate with Victim # 1.

The school provided me emails between Taylor and Victim #1. There were 140 pages of emails in a two-week period.

On February 26, 2025, I went to Taylor's home again. I warned him for telecommunication harassment.

On March 2, 2025, VR #1 let me know that Victim # 1 received another email from Joseph Taylor.

On March 3, I received a call from VR #2, and she said that Taylor is still trying to contact Victim # 1 by reaching out to friends and family members and stalking her friends on social media sites. At school, Taylor tried to trip Victim # 1. She said that this has been reported to the school.

Both parents of Victim # 1 requested charges be filed on Taylor.

On March 12, 2025, I went to Coldwater Schools to speak with Victim #1. She reported that Taylor's continued attempts to contact her have been causing her and her family significant stress and causing her to fall behind on her school work.
