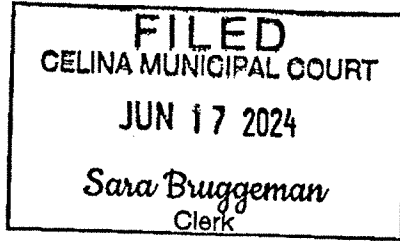



COMPLAINT BY INDIVIDUAL  
(RULE 4)

Complainant, being duly sworn, states that Andrew A Leininger on or about June 16, 2024 in Mercer County, Ohio, did No person shall knowingly cause another to believe that the offender will cause serious physical harm to the person or property of the other person, the other person's unborn, or a member of the other person's immediate family. In addition to any other basis for the other person's belief that the offender will cause serious physical harm to the person or property of the other person, the other person's unborn, or a member of the other person's immediate family, the other person's belief may be based on words or conduct of the offender that are directed at or identify a corporation, association, or other organization that employs the other person or to which the other person belongs TO WIT: Andrew A Leininger pulled a taser out and tased Victim #1 in the stomach. Andrew then pulled out a pocket knife from his pocket and pointed it at Victim #1. This is contrary to and in violation of Ohio Revised Code section 2903.21 (A) titled Aggravated Menacing a Misdemeanor of the 1st degree.
