AFFIDAVIT ON COMPLAINT (O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Christopher Hamberg, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

I was dispatched to 325 South Main Street, in the Village of Mendon, Mercer County, Ohio to initiate a missing person's report. I contacted victim # 2 who said that Victim # 1, a 15-year-old child, was missing. Victim # 2 went on to say that the last persons to see him would have been his siblings, which would have been on the evening of March 4, 2025. The siblings said that Victim # 1 continually checked in on them, once they went to bed. Victim # 2 felt that he was checking on them, to know when they fell asleep. Victim # 2 told me that at about 2:15 A.M, the surveillance cameras at the rear of the home were turned, to avoid catching further video footage. All of the bicycles and scooters were still at home, feeling that someone had picked him up in a vehicle.

I took his personal and clothing description. Victim # 2 has reached out to a good friend of Victim # 1's that lives nearby. He hasn't seen him either. I was told that Victim # 1 has a biological mother that lives in Indiana. Her name is Alicia Nicholson. He also has a biological brother. Victim # 2 was not sure if he would go there or not. I completed a missing persons form with Victim # 2, to grant our Agency the ability to enter Victim # 1 as a missing juvenile.

Later this same date, I was notified by Victim # 2, that they had accessed Victim # 1's "Snapchat" account and saw that he had been communicating with his biological mother, Nicholson, as well as phone calls, the night before, but had been deleted.

I confirmed with Mercer County Job and Family Services that Nicholson has no parental rights to the child.

While investigating, we were told that both Victim # 1 and Nicholson had cell phones. We contacted the two different cell phone providers for assistance and were told that Victim # 1's phone was turned off. Nicholson's cell phone provider did an emergency "Ping' on her phone and phone that it had been used and "Pinged" to Cement City, Michigan.
