did with purpose to deprive the owner, Victim # 1, of property or services, to wit: \$1309.16 worth of store merchandise, knowingly obtain or exert control over either the property or services by deception.

FURTHERMORE, the property or services stolen is valued at one thousand dollars or more and less than seven thousand five hundred dollars.

The Grand Jurors further find and specify that:

Rachel R. Clark is the owner and/or possessor of a 2017 Dodge Journey SXT, VIN number 3C4PDCBG7HT697115, which was contraband and/or property derived from or through the commission or facilitation of the offense, and/or was an instrumentality the offender used or intended to be used in the commission or facilitation of the offense, which is subject to forfeiture pursuant to 2941.1417(A) and 4503.234 of the Revised Code.




