did with purpose to deprive the owner, Victim # 1, of property or services, to wit: \$6567.35 worth of business product, knowingly obtain or exert control over either the property or services by deception.

FURTHERMORE, the property or services stolen is valued at one thousand dollars or more and less than seven thousand five hundred dollars.
