AFFIDAVIT ON COMPLAINT (O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Justin Bruns, do hereby state that I am employed at the Celina Police Department. The following did occur:

On March 2, 2025, at approximately 4:13 A.M, I was sitting stationery in the 1100 Block of North Main Street, in the City of Celina. I saw a brown Ford truck that had no taillights illuminating. It turned Northbound from Myers Road, onto North Main Street. I initiated a traffic stop on the truck, which was a 2020 Ford F150 bearing Ohio registration EZD4516.

I contacted the sole occupant, a female driver that was identified as Elaine A. Sutton. I asked for her driver's license and proof of insurance card. While she was looking for the insurance information, I noticed a rolled-up paper towel sitting in her lap, half tucked under her shirt. From my training and experience, I know this to be a way of transporting a glass pipe, which is used for smoking crack cocaine. Beside the rolled-up paper towel was a small black and purple bag sitting between her legs. I asked her what was in the bag, to which she replied, nothing. I asked if I could look inside the bag. She agreed and handed me the bag. Inside the bag I saw rolled up copper wire, which is also used when smoking crack cocaine. I asked Sutton if there were any drugs in the car which she said no. I told her I saw the rolled-up copper wiring, or commonly called "chore boy." She said that she does have crack on her.

I asked her to step out of the truck. I was checking her person, and she said that she has a pipe in her right leg cargo pants pocket. I then located the pipe. Sutton said that the crack was down the front of her pants. She reached in and pulled out a clear plastic container containing a white rock like substance, that I again, recognized from my training and experience with drugs of abuse, as crack cocaine.

Sutton was taken into custody and transported to the Mercer County Detention facility.
