STATE OF OHIO, MERCER COUNTY, SS:

I, do hereby state that I am employed at the Celina Police Department. The following did occur:

On June 8, 2024 at approximately 5:20 P.M, I was dispatched to the "Burger King" restaurant, located at 209 East Market Street, Celina, Ohio for a complaint of a male being impaired, on a bicycle. He was described as having no shirt or shoes.

I arrived and located the male. He was on a bicycle with a pull behind trailer. He was identified as William "Bill" Fetters.

I made contact with Bill and he appeared to be under the influence and from my training and experience, drugs of abuse were causing his impairment. Bill's movements were quick and jerky. He could not stand still. His speech was impaired and he could hardly say his own name. I had Bill step off of his bicycle and tried to have him perform standardized field sobriety tests, but his impairment made it complicated.

I placed Fetters under arrest and transported him to the Mercer County Jail. I read Bill his Miranda warning. I also read him the BMV form 2255, for the potential OVI charge. The jail staff required that Fetters get medically cleared, before they would book him into the jail.

I transported him to Mercer Health Hospital in Coldwater, Ohio. While waiting for his evaluation, Bill admitted to me that he smoked methamphetamine, earlier this date. He then admitted to having methamphetamine in his wallet. I did locate a piece of tin foil wrapped up. Inside the tin foil was a crystal like substance that I know to be methamphetamine. Fetters was examined, cleared for incarceration, and booked into the Mercer County Jail.

Some of the contents of the tin foil was tested and tested positive for methamphetamine. Its weight is approximately one gram or less.
