STATE OF OHIO, MERCER COUNTY, SS:

I, Zac Nelson, do hereby state that I am employed as an officer with the Celina Police Department. The following did occur:

On or about October 11, 2024 at approximately 9:00 PM, I was on routine patrol in the City of Celina, Mercer County, Ohio when I observed a black Chevrolet sedan stopped in the roadway in the 400 block of South Mill Street. A passenger was exiting the vehicle. I conducted a registration check of the vehicle through my in-car LEADS system. The result showed that the driver's license of the registered owner of the vehicle, Gaven Buschur, was suspended.

The vehicle then failed to signal prior to 100 feet of the intersection of South Mill Street and Washington Street and changed directions of the signal before turning east onto Washington Street. I conducted a traffic stop and made contact with the driver, Gaven Buschur.

I asked Gaven for insurance information. While doing so, he kept fidgeting. I asked him if there was anything in the vehicle that I should know about. He stated there was an airsoft gun under his seat. He then proceeded to reach for it. I told him to stop reaching. I ordered him again to stop reaching, as he continued to reach. I then advised him to step out of the vehicle for officer safety. While he was exiting the vehicle, I asked if there were any narcotics in the vehicle. Gaven advised that there shouldn't be. I asked Gaven for consent to search the vehicle, but he refused.

Also while Gaven was exiting the vehicle, I observed his right hand was clenched. Gaven then, once again, reached back under the driver's seat where he indicated the air soft gun was located. I told him to stop reaching. I asked Gaven what was in his hand. Gaven stated that it was just a bag. I told him to put it on the driver's seat. Gaven did not listen and tried to hide the bag under the driver's seat, again reaching towards the location where Gaven had said the air soft gun was located. I asked Gaven again what was in the bag. He stated that he didn't know, maybe some bath salts. I asked him if the bag contained meth, and he confirmed that the bag contained meth. I then patted Gaven down. Nothing was found, and I detained him.

Patrolman Kerr and Patrolman Bruns were on scene and assisted in the search of Gaven's vehicle. Under the driver's seat, I located a clear baggie with a crystal-like substance that through my training and experience, I know to be methamphetamine. I also located a Glock BB gun that appeared to look like a real handgun.

Gaven was placed under arrest and read his *Miranda* warnings. He stated that the bag contained methamphetamines and told us from whom he had gotten the methamphetamines. Gaven was then transported to the Mercer County Jail.
