
Your Honor:

On July 7, 2024, Officers from the Greenville Police Department were dispatched to 527 East Main Street in the city of Greenville, Darke County, Ohio in reference to a sexual offense. Upon officers' arrival and through investigation, it was discovered the defendant resides at this residence with his wife, step-children, as well as his natural children. The defendant's wife, Kara Harter, reported that she located an application on the defendant's cell phone in which shows a hidden camera view of her daughter's bedroom. Upon Kara's investigation, she located a hidden camera inside of a smoke detector in her daughter's bedroom. Kara was unaware nor did she give the defendant permission to record in any of the bedrooms in the residence. The defendant signed a consent to search form and allowed officers to search his cell phone. During a search of the defendant's cell phone, officers located multiple images which portrays person(s) under the age of 18 years old nude. One of the photo's shows a 17-year-old female partially nude with her vagina exposed while changing clothes. The photo appeared to be a still shot image from the hidden camera that was in the defendant's stepdaughters' bedroom.

On July 8, 2024, this case was assigned to me by Lieutenant Bengel. I arranged for the juvenile victim(s) to be interviewed at the Child Advocacy Center in Union City, Indiana. The victim was unaware there was a hidden camera in the bedroom, and she did not give anyone permission to do so.

On July 8, 2024, the defendant agreed to come to the Greenville Police Department to speak with me about this investigation. The defendant was advised of the Miranda Warnings to which he signed, advised he understood, and agreed to speak with me about the investigation. The defendant admitted to putting the cameras up in the bedroom and capturing still images and videos of the juveniles while they were nude. The defendant also knew that what he was doing was wrong and an invasion of privacy to the victim(s) but he did not remove the camera. The defendant was placed under arrest and transported to the Darke County Sheriff's Office where he was incarcerated without bond.
