STATE OF OHIO, MERCER COUNTY, SS:

I, Patrolman Zac Nelson, do hereby state that I am employed at the Celina Police Department. The following did occur:

On January 7, 2025, I was dispatched to 1258 Myers Road, in the City of Celina, Mercer County, Ohio, to investigate a complaint of a male that had crashed his motor vehicle and may need medical assistance.

When I arrived, I saw a tan, in color, Lincoln sedan that had collided with a vehicle, on the South side of the roadway. I saw a male that appeared passed out, in the driver's seat and slumped over the steering wheel. I searched for needles for the safety of the squad members. I did feel a large plastic baggie in his right-side pocket. The male started to wake up and became agitated. At this time, I could observe his pupils and noticed they were extremely dilated, which is a sign of drug use.

The male, identified as a Jerrod W. Muhlenkamp, was pulled from the vehicle and placed onto a gurney, and escorted into the ambulance. I assisted the squad members with removing Muhlenkamp's clothing. In his sweatshirt pocket, I felt a glass pipe. I took it out of the pocket and found that it was a glass pipe, with burnt residue in the bowl, that from my training and experience, is a pipe used for smoking methamphetamines. In his right pocket, I found two plastic baggies. One baggie had a large amount of a crystal-like substance. The other baggie had a residue of a white powdery substance.

Muhlenkamp was transported by squad to Mercer Health in Coldwater, Ohio. I followed the squad. At the hospital, I read Muhlenkamp his Miranda warning and also BMV OVI form 2255. He refused to provide any samples, blood or breath.

At the Police Department, the contents of the large plastic baggie were tested. It tested positive for methamphetamine and weighed 18 grams. The residue in the second baggie also tested positive for methamphetamine. The items collected are placed into evidence to be sent to the Ohio Attorney General's BCI Office for further testing.
