STATE OF OHIO, MERCER COUNTY, SS:

I, Patrolman Zac Nelson, do hereby state that I am employed at the Celina Police Department. The following did occur:

On March 24, 2025, at approximately 7:14 P.M, I was travelling Eastbound on East Wayne Street, in the City of Celina, Mercer County, Ohio when I saw a gold Chrysler van travelling Westbound on East Wayne. I could see a passenger in the vehicle and recognized him as Donald "Bill" Lange. I was aware that there was an active warrant for the arrest of Donald Lange.

I turned around and followed the van. I watched as the van approached the intersection of North Buckeye Street and East Market Street and noticed that the driver failed to signal when making a turn, prior to 100 feet. I initiated a traffic stop.

I made contact with three occupants. Donald Lange was the front seat passenger, and Constance Lange was the back seat passenger. I knew Donald and Constance both had warrants for their arrest, through the Mercer County Sheriff's Office. They were both placed under arrest and placed into my cruiser. I then spoke with the driver. She verbally identified herself as Alicia Teeters, and her date of birth as September 15, 1980. I had Dispatch run her information for driving status. I was told that she was not valid. I told that to Teeters and she said that she was valid. I then utilized by in-car computer to view a LEADS photo of Alicia Tetters driver's license and it did not match.

Sgt. G. Bartlett was on scene as well. He spoke with Donald and Constance Lange and asked them what the driver's name was, and they said Stephanie Jaynes. I viewed a driver's license photo of Jaynes, and it matched the driver. I was also told that there was an arrest warrant for Stephanie Jaynes.

I requested a K-9 dog to come to my location. Sgt. Parker from the St. Mary's Police 2 5 2025

Department came to my location and his dog, Mattis did a free air sniff around the vehicle.

Afterwards, I was told that the dog alerted to the presence of an odor of narcotles. CELINA, OHIO

We conducted a search of the vehicle. I did locate the identification card belonging to Stephanie Jaynes. Officers located a red bag in the center rear console. Inside the bag was a white purse. Inside the bag were two clear baggies with a clear crystal -like substance. From my training and experience, I know this to be methamphetamine. Also in the bag, we located

All three occupants were transported to the Mercer County Detention Facility.

Afterwards, the contents of the baggie were tested and tested positive for methamphetamine.
