STATE OF OHIO, MERCER COUNTY, SS:

I, Deputy Will Fox, do hereby state that I am employed at the Mercer County Sheriff's Office. The following did occur:

On November 15, 2024 at approximately 11:46 A.M, I was dispatched to an injury accident. The accident was on West Main Street, in Franklin Township, Mercer County, Ohio.

When I arrived, the sole occupant was out of the vehicle and sitting by a tree, speaking with a first responder. The vehicle had collided with a tree. I contacted the driver, and she identified herself as Chelsey Mills. She told me that she had an Identification Card and a check through Dispatch showed that she was under a driving suspension. While speaking with Mills, I could see signs of impairment. She was talkative, speaking fast, her eyes were bloodshot, and her pupils were "pinpoint".

I attempted to run Mills through a series of field sobriety tests, but she refused. I performed a Horizontal Gaze Nystagmus test on her viewing six out of six possible indicators. I told her she was being placed under arrest for operating a vehicle while under the influence. I asked her to drop the belongings she had in her hands, which she did. She also dropped a backpack she had on. While placing her into a cruiser, she said that she was in pain and needed to go to a hospital.

I asked if there was anything in the backpack. She said no. I picked up a blanket she had dropped. Underneath, I found two baggies. One was full of white powdery substances. The second, full of a clear crystal-like substance. I asked Chelsey what it was, and she said cocaine.

At the hospital, Sgt. Westgerdes met me there. He asked Mills about the baggies. She said that she does cocaine and methamphetamine, but the ones we found don't belong to her.

Mills was cleared for incarceration and transported to the Mercer County Detention Facility.

The contents of the two baggies were tested. One tested positive for cocaine and weighed 4.33 grams. The second baggie tested positive for methamphetamine and weighed 9.9 grams. Also in the backpack, we located a scale with residue, a burnt foils pipe with residue, a card with Mills name on it and \$432.00 in cash.
