Date of Offense On or about September 28, 2022 to September 27, 2023

The Grand Jurors do further find and present:

was eighteen years of age or older, to wit: Randy L. Wyerick was born on 09/12/1960, and did engage in sexual conduct with another person, Victim #1, who was not the spouse of the offender, when the offender knew the other person was thirteen years of age or older but less than sixteen years of age, or the offender was reckless in that regard, to wit: Victim #1 was born on 09/28/2009.

FURTHERMORE, Furthermore, the offender is at least four years older than the other person with whom the offender engaged in sexual conduct and the offender was ten or more years older than the other person.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

The Grand Jurors do further find and present:

Count Five Unlawful Sexual Conduct With a Minor - F3

FURTHERMORE, Furthermore, the offender is at least four years older than the other person with whom the offender engaged in sexual conduct and the offender was ten or more years older than the other person.

The offense is contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.


