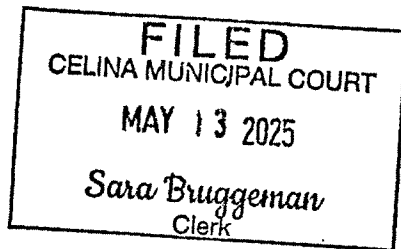

Ruwoldt while employed with Victorium Early Learning Center did have control and supervision while in a toddler room. Video surveillance shows Jayne Ruwoldt walking over to assist teacher, Jordan Foust, who was currently with victim #1. Jayne Ruwoldt grabs victim #1 by both arms and picks victim #1 up. Jayne Ruwoldt then forcibly pushes victim #1 up against the wall. Victim #1 is restrained by Jayne Ruwoldt up against the wall while not being permitted to leave for several minutes. This is contrary to and in violation of Ohio Revised Code section §2903.13A, titled Assault, a Misdemeanor of the first degree.

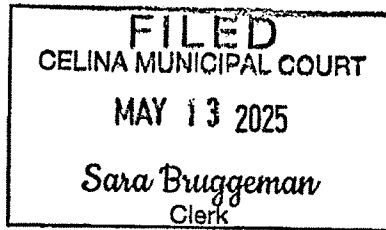

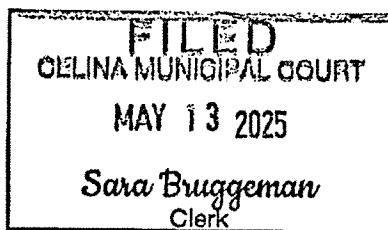

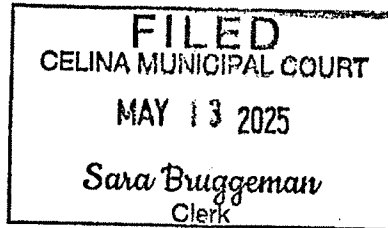
