AFFIDAVIT ON COMPLAINT

(O.R.C. 2935.09)

STATE OF OHIO, MERCER COUNTY, SS:

I, Sgt. Colin Fuelling, do hereby state that I am employed at the Celina Police Department. The following did occur:

On December 15, 2024 at approximately 1:37 P/M, I was made aware of a theft in progress at Victim # 1, located at 1950 Havemann Road. As I was responding, the Asset Protection Manager called me and told me that they had a second theft in progress. He was going to direct his attention to that male. A second Asset Protection employee started following this person through the store. They knew this male because he had committed push out thefts on previous dates and the Manager had sent me a photo of him.

When I arrived, the AP Manager pointed out the suspect vehicle, which was still in the parking lot. I ran the registration on the vehicle, and it came back to a person that lives at South Street, Celina, Ohio.

The Manager told me that this male would select items and place them into plastic bags, that he brought into the store. He would then walk out with the items, passing all points of sale without paying.

I was told the male was on the pharmacy side of the store preparing to exit. I saw the male outside, by the parking spaces pushing the cart. He matched the clothing description I was given and matched the picture I had been sent previously.

I contacted the male and he said that he didn't understand English. I used a translating device to communicate with him. Through that, he acknowledged he was stealing from the store. We went back inside the Loss Prevention Office.

Once inside, I read him Miranda. He identified himself as Richard Garcia-Mejias and provided me a Venezuelan identification card. He said that he resides at 915 South Street, Celina, Ohio. We located a female employee that could help translate. Victim # 1 had three previous thefts that Garcia-Mejias was a suspect in. Garcia-Mejia confessed to those.

The store merchandise that was stolen today had a total value of \$617.35. There were two thefts on December 12, 2024. One loss was \$226.80. The other was \$113.69. On December 13, 2024, Garica-Mejias committed a theft with a value of \$232.15. The total value of all the store merchandise stolen was \$1,189.99.
